## RESOLUTION ADOPTING AN AMENDMENT TO THE LAKE **GENERAL PLAN POLICY GUENOC VALLEY MIXED USE PLANNED DEVELOPMENT PROJECT**

WHEREAS, the uses allowed within the Land Use Designation and General Plan Designation are

WHEREAS, The Board of Supervisors has independently reviewed and evaluated the CEQA Findings of Fact and Statement of Overriding Considerations referenced herein; and

WHEREAS, the Planning Commission found the EIR to be in compliance with the California Environmental Quality Act (CEQA) and the State CEQA Guidelines; and

WHEREAS, on August 8, 2025, at a duly noticed public hearing, the Planning Commission certified the Final EIR that was prepared for Guenoc Valley Mixed Use Planned Development Project and adopted the CEQA Findings of Fact and Statement of Overriding Considerations.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE, THAT IT FINDS, DETERMINES, ORDERS AND HEREBY DECLARES AS FOLLOWS:
