**Article XV, Section A**, "Modification" of the AGREEMENT FOR ENGINEERING SERVICES FOR REPLACEMENT OF CLOVER CREEK BRIDGE AT FIRST STREET (14C-0015) IN LAKE COUNTY, dated February 28, 2017, allows that matters concerning scope of service which do not affect the agreed price may be modified by mutual written consent of CONSULTANT and COUNTY, executed by Director of Public Works.

The CONSULTANT and COUNTY wish to extend the term of the AGREEMENT. With the execution of Amendment Six, the AGREEMENT shall continue in full force and effect until December 31, 2025. This AMENDMENT shall not affect the agreed upon compensation.

Except as specifically modified herein, all terms and conditions of the AGREEMENT dated February 28, 2017, Amendment One to AGREEMENT dated September 18, 2018, Amendment Two to AGREEMENT dated October 22, 2020, Amendment Three to AGREEMENT dated November 29, 2021, Amendment Four to AGREEMENT dated September 13, 2022, and Amendment Five to AGREEMENT dated December 20, 2022, shall remain in full force and effect.
