# Amendment to CLA Accounting and Advisory Services Statement of Work County of Lake Date: March 11, 2025

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, CliftonLarsonAllen LLP (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
