SUBJECT: Proposed ordinance re: cannabis manufacturing, distribution and testing

EXECUTIVE SUMMARY:

The Board of Supervisors directed the staff to prepare an ordinance addressing the manufacturing and distribution of cannabis. At the March 22nd Planning Commission meeting the Commission passed a resolution of intent to amend Article 27 to address the manufacturing, distribution, and testing of cannabis. The staff has prepared a proposed ordinance.

The proposed ordinance has four major parts. The first, starting at Section 3 addresses manufacturing. Distribution is addressed in Section 4 and testing in Section 5. These three parts are formatted similarly to the cannabis cultivation ordinance recently passed by the Board. The fourth part, Sections 7 through 10 address cleanup items related to the cultivation ordinance. Attached is an outline of the proposed ordinance.

RECOMMENDED ACTION: Review the proposed ordinance regarding the regulation of cannabis manufacturing, distribution, and testing and make a recommendation to the Board of Supervisors.
