**RESOLUTION AUTHORIZING APPROVAL, ADOPTION, CERTIFICATION, AND SUBMISSION OF THE LAKE COUNTY BEHAVIORAL HEALTH SERVICES BEHAVIORAL HEALTH SERVICES ACT INTEGRATED PLAN FOR FISCAL YEARS 2026-2027, 2027-2028, AND 2028-2029**

WHEREAS, in November 2004, California voters approved Proposition 63, the Mental Health Services Act, to expand and transform California county mental health service systems; and

WHEREAS, in March 2024, California voters approved Proposition 1, which amended and renamed the Mental Health Services Act as the Behavioral Health Services Act and established updated requirements for county behavioral health planning, services, expenditures, reporting, oversight, transparency, and accountability; and

WHEREAS, Lake County Behavioral Health Services is required to prepare and submit a Behavioral Health Services Act Integrated Plan for the three-year period covering Fiscal Years 2026-2027, 2027-2028, and 2028-2029; and

WHEREAS, Lake County Behavioral Health Services has prepared the Behavioral Health Services Act Integrated Plan for Fiscal Years 2026-2027, 2027-2028, and 2028-2029 in accordance with applicable state law, regulations, and guidance; and

WHEREAS, Lake County Behavioral Health Services has conducted the required community planning process, public review process, Behavioral Health Board review, and public hearing process for the Behavioral Health Services Act Integrated Plan; and

WHEREAS, the Lake County Board of Supervisors has reviewed the Behavioral Health Services Act Integrated Plan for Fiscal Years 2026-2027, 2027-2028, and 2028-2029; and

WHEREAS, the California Department of Health Care Services requires a Board of Supervisors Certification Form confirming that the Board of Supervisors has reviewed and approved the Integrated Plan and including required certifications related to realignment obligations pursuant to Welfare and Institutions Code section 14197 and other applicable guidance; and

WHEREAS, the Board of Supervisors desires to approve and adopt the Behavioral Health Services Act Integrated Plan and authorize execution and submission of all required certifications, attestations, budgets, and supporting documents necessary to complete the Integrated Plan submission process;

**NOW, THEREFORE, BE IT RESOLVED** that the Lake County Board of Supervisors hereby approves and adopts the Lake County Behavioral Health Services Behavioral Health Services Act Integrated Plan for Fiscal Years 2026-2027, 2027-2028, and 2028-2029.

**BE IT FURTHER RESOLVED** that the Board of Supervisors authorizes the Chair of the Board of Supervisors to sign the Board of Supervisors Certification Form required for the Behavioral Health Services Act Integrated Plan, including required certifications related to the County's realignment obligations pursuant to Welfare and Institutions Code section 14197 and other applicable guidance.

**BE IT FURTHER RESOLVED** that the Board of Supervisors authorizes Lake County Behavioral Health Services, through its Behavioral Health Director or designee, to submit the Behavioral Health Services Act Integrated Plan and all required certifications, attestations, budgets, and supporting documents to the California Department of Health Care Services and any other required state oversight entity.

**BE IT FURTHER RESOLVED** that the Behavioral Health Director or designee is authorized to make any non-substantive, technical, clerical, or conforming changes necessary to complete the Integrated Plan

submission, provided such changes do not materially alter the programs, expenditures, or policy direction approved by the Board of Supervisors.
