

AMENDMENT NO. 4 TO AGREEMENT TO SERVICES CONTRACT BETWEEN COUNTY OF LAKE AND MITCHELL HAUPTMAN FOR INDIFENT SERVICES

This Amendment No. 4 to Agreement is made and entered into this ____ day of _____ by and between the COUNTY OF LAKE, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and Mitchell Hauptman (hereinafter referred to as "CONTRACTOR").

RECITALS

WHEREAS, the original Agreement was entered into on July 1, 2024; and

WHEREAS, the parties desire to amend the Agreement to increase the total compensation;

NOW, THEREFORE, the parties hereby agree as follows:

A. Section 2 is hereby amended to read:

"2. COMPENSATION.

Contractor has been selected to provide conflict indigent defense representation. Total compensation to Contractor shall not exceed **One Hundred Fifty-Thousand Dollars (\$150,000.00)**; with the said sum to be paid only on the basis of hourly work performed pursuant to this Agreement. The hourly rate to be paid to Contractor shall be \$75 (Seventy Five Dollars) an hour for level 1 cases (0-7 year potential prison terms). \$100 (One Hundred) an hour for level 2 cases (8+ year potential prison terms, up to 40 years), and \$110 (One Hundred Ten Dollars) an hour for cases where Defendant's initial punitive exposure is an indetermined life term or a term of 40 years or greater.

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
