AMENDMENT ONE TO THE ENGINEERING SERVICES AGREEMENT FOR STAFF AUGMENTATION SERVICES IN LAKE COUNTY, CALIFORNIA

This Amendment One to the Engineering Services Agreement is made this 21st day of May, 2024, by and between the County of Lake, hereinafter referred to as "COUNTY", and Coastland Civil Engineering, LLP, hereinafter referred to as "ENGINEER".

WITNESSETH

WHEREAS, COUNTY and ENGINEER have entered into an Engineering Services
Agreement dated November 14th, 2023, to provide on-call staff augmentation services for the
Engineering and Inspection Division of the Department of Public Works; and

WHEREAS, the Engineering Services Agreement defines the period of performance as one (1) year from the date of approval; and

WHEREAS, the Engineering Services Agreement provides for additional funding to be added to the contract for the following year's service; and

WHEREAS, COUNTY AND ENGINEER now desire to amend said Engineering Services Agreement to adjust the period of performance to coincide with the standard County Fiscal Year.

NOW, THEREFORE, the parties hereto agree as follows:

Section 14 is hereby modified to read as follows:

"14. Payment for services covered by this AGREEMENT shall be made on a Time and Material basis, with a not-to-exceed total of \$250,000.00 for the fiscal year beginning on July 1st of the next fiscal year. Amendments will be executed annually to revise the not-to-exceed total for the following year and to adjust personnel rates as needed. Rates paid for the various classifications of workers shall be in accordance with the Rate Steet included as Attachment "A" to this AGREEMENT. General staff oversight is expected to be performed by individuals at a "Supervising Engineer" or lower, and any tasks requiring a Principal Engineer must be pre- approved by the COUNTY prior to the work. ENGINEER shall provide a written scope of services together with an estimate of staff hours and cost and receive authorization from COUNTY prior to beginning work on specific projects. Staff charges will be summarized by project, with a separate category for general oversight. All ENGINEER charges for services between November 14, 2023 and June 30th, 2024 will be reimbursed and counted towards the 2023/24 Fiscal Year."

Except as specifically modified herein, all other terms and conditions of the Engineering Services Agreement dated November 14th, 2023, shall remain in full force and effect.

COUNTY and ENGINEER have executed this Amendment One to the Engineering Services Agreement on the day and year first written above.
