APPROVE RESOLUTION TO AMEND THE ADOPTED BUDGET FOR FY 2019-20 BY APPROPRIATING UNANTICIPATED REVENUE IN THE AMOUNT OF \$10,000 FOR BUDGET UNIT 5321 – VETERANS SERVICES IN SUPPORT OF MENTAL HEALTH OUTREACH AND OTHER RELATED RECOVERY TREATMENT PROGRAMS

WHEREAS, Government Code Section 29130 provides that unanticipated revenue may be made available for specific appropriation by a four-fifths vote of the Board at any regularly scheduled or properly noticed special meeting; and

WHEREAS, the Veterans Services Department recently received an additional one time funding award from the State of California in support of Proposition 63 to expand and enhance county mental health services for Veterans, including treatment and other related recovery programs for Fiscal Year 2019-2020 in the amount of ten thousand dollars and 0/100 cents \$10,000; and

WHEREAS, this funding will be used to support the Veterans Services Department in support of mental health outreach and treatment programs. It is not intended to cover overall agency expenses, major capital expenses or other unrelated expenses; and

WHEREAS, it is necessary to appropriate said revenue into the Lake County Department of Veterans Services Budget in order to use the funds.

NOW, THEREFORE, BE IT RESOLVED THAT, the Board of Supervisors of the County of Lake, State of California, that it finds, determines, and hereby declares that the County of Lake Adopted Budget for Fiscal Year 2019/2020 is amended as follows:
