The Agreement by and between the Secretary of State and Lake County is hereby amended as follows:

1. Exhibit A, Section D. Matching Funds. is hereby replaced in its entirety, as stated below:

Counties with 51 or more precincts as of November 8, 2016, may seek reimbursement where the county has spent matching county funds on voting systems replacement activities on a dollar-for-dollar basis, up to the maximum amount of funds allocated for the contract. three-to-one basis (75%) up to the maximum amount of funds allocated for the contract.

Counties with 50 or fewer precinct as of November 8, 2016, are not required to provide matching funds and may seek reimbursement on a dollar-todollar basis (100%) up to the maximum amount of funds allocated for the contract.

Matching funds may also include federal funds such as Help America Vote Act (HAVA). State funds, such as Voting Modernization Bond Act of 2002 (VMB) may not be used as matching funds.

2. Exhibit B, Section 7. Retroactive Payments is hereby replaced in its entirety, as stated below:

7. Retroactive Payments

Counties may claim reimbursement for expenses and activities permissible under the terms of this Agreement that occur after April 29, 2015, and before August 31, 2026.

All other terms and conditions shall remain the same.
