BOARD OF SUPERVISORS NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN The Lake County Hospital Improvement District (LCHID) is a proposed business-based assessment district. The LCHID assessment would apply to two businesses - Adventist Health Clear Lake and Sutter Lakeside Hospital (Hospitals). The assessment would be 6 percent of the Hospital's net patient revenue and is projected to raise approximately \$15,300,000 its first year and on average approximately \$16,900,000 per year of the proposed five-year term. The assessment would be paid to the State of California Department of Health Care Services (DHCS). DHCS may use broad based healthcare related taxes to cover the nonfederal share of Medi-Cal expenditures, which is then used to calculate the Federal Financial Participation (FFP) of the Medi-Cal program. The intended goal of the LCHID improvements is to reduce the unreimbursed costs incurred by the Hospitals by increasing the FFP through the assessment. More than half of Lake County residents rely on Medi-Cal and therefore an increased FFP would provide fiscal stability to the Hospitals. The assessment would be administered by the County of Lake Office of Treasurer Tax-Collector on a guarterly basis. The public meeting for the assessment will occur on October 22, 11:00 A.M., 2024, and the public hearing will occur on November 5, 11:00 A.M., 2024. Both the public meeting and public hearing will occur in the Board of Supervisors chambers located at 255 N Forbes Street, Lakeport, CA 95453. To receive additional information of the proposed assessment please contact Deputy County Administrative Officer Ben Rickelman, (707) 263-2580, at 255 N Forbes Street, Administration Office, Lakeport, CA 95453, Business owners who would be impacted by the assessment may mail a protest to Ben Rickelman at the same address. A majority protest of the businesses, based on assessment value, that would be assessed will cause the assessment to be abandoned.
