

**FIRST AMENDMENT TO CONTRACT BETWEEN THE COUNTY OF
LAKE AND CHABOT-LAS POSITAS COMMUNITY COLLEGE
DISTRICT FOR TITLE IV-E SPECIALIZED TRAINING**

This first amendment to Contract is made and entered into on the date executed herein below, between the County of Lake through its Department of Social Services, hereinafter referred to as “LCDSS”, and Chabot-Las Positas Community College District, hereinafter referred to as “Contractor”; collectively referred to as the “parties”.

WHEREAS, the original Contract was executed on September 10, 2024 for the term of July 1, 2024 to June 30, 2027; and

WHEREAS, due to a clerical error the wrong version of the Contract was submitted and approved by the Board of Supervisors, and

WHEREAS, there is a need to correct the Compensation to reflect the intended amount, and

WHEREAS, there is a need to remove the Waiver of Subrogation clause from the contract.

NOW, THEREFORE, the parties hereto agree as follows:

Page 1, Section 2 entitled “COMPENSATION” is hereby amended to read:

“Contractor has been selected by LCDSS to provide the services described hereunder in Exhibit “A” (Scope of Services), incorporated herein by this reference. Compensation to Contractor shall not exceed one million dollars (\$1,000,000.00) per fiscal year.

LCDSS shall compensate Contractor for services in accordance with Exhibit “B” (Fiscal Provisions), attached hereto and incorporated herein. Compensation to Contractor is contingent upon appropriation of federal, state and county funds.”

Page 11, Section 11, Subsection F entitled “Other Insurance Provisions”, Paragraph 6 shall be removed from the contract:

6. ~~“Contractor agrees to waive all rights or subrogation against County of Lake, its officers, officials, employees, agents, and volunteers for losses arising from work performed by Contractor under this Contract.”~~

Except as specifically modified herein, all other terms and conditions of the original Contract shall remain in full force and effect.
