RESOLUTION APPOINTING DIRECTORS OF CERTAIN

WHEREAS, California Elections Code Section 10515 et seq. states that if a Declaration of Candidacy has been filed by only one person, by no person, or if the number of persons who have filed does not exceed the number of offices to be filled, the supervising authority of the County shall make appointments to the District; and
