The tour will highlight ongoing conservation initiatives, the park’s partnership work with local communities, and the challenges and opportunities of stewarding fragile ecosystems in a high-visitor environment.</p> <p>Throughout the day, participants will visit key sites within the park and hear from National Park Service staff and local partners about habitat restoration, visitor management strategies, and the cultural significance of Haleakalā’s landscapes.
