A RESOLUTION TEMPORARILY AUTHORIZING A ROAD CLOSURE, PROHIBITING PARKING AND AUTHORIZING REMOVAL OF VEHICLES AND ORDERING THE DEPARTMENT OF PUBLIC WORKS TO POST SIGNS

WHEREAS, the Kelseyville Business Association has scheduled the Kelseyville Pear Festival Farm to Fork Dinner and Street Dance to be held from 5 p.m. to 11:00 p.m. September 26, 2025; and

WHEREAS, Main Street, County Road No. 522V, Second Street, County Road No. 522B, Third Street, County Road No. 522C, and Fourth Street, County Road No. 522D, will need to be closed in order to provide an adequate and safe area for tables and stages; and

WHEREAS, Gunn Street, County Road No. 522G; Live Oak Drive, County Road 516 and State Street, County Road No. 522 will provide an adequate and safe route for a detour around said blocked County roadways; and

WHEREAS, Section 21101, subdivision (e) of the Vehicle Code authorizes this Board to temporarily close a portion of any street where signs are posted giving notice of the closure; and

WHEREAS, Section 22651, subdivision (n) of the Vehicle Code, authorizes this Board to prohibit parking and to remove vehicles where signs are posted giving notice of the removal.

NOW, THEREFORE, the Board of Supervisors of the County of Lake does hereby find, determine, resolve and order as follows:

- 1. No person shall operate any vehicle in the following locations from 12:00 p.m. September 26, 2025, through 12:00 a.m. on September 27, 2025:
  - (a) On Main Street, County Road No.522V, from its intersection with Second Street, County Road No. 522B to its intersection with Fourth Street, County Road No.522D.
- 2. No person shall park any vehicle in the following locations from 12:00 p.m. through 11:59 p.m. on September 26, 2025:

- (a) On Main Street, County Road No.522V, from its intersection with Second Street, County Road No. 522B to its intersection with Fourth Street, County Road No.522D.
- 3. All vehicles parked in violation of this Resolution may be removed as provided by law.
- 4. The Department of Public Works or its designee shall post signs giving notice of the removal as provided in Section 22651, subdivision (n), of the Vehicle Code.
