

**Amendment No. 3 to AGREEMENT BETWEEN THE COUNTY OF LAKE AND  
MANAGEMENT CONNECTIONS FOR TEMPORARY CLERICAL PERSONNEL IN THE  
COUNTY LAKE HUMAN RESOURCES OFFICE**

This Amendment No. 3 to Agreement is made and entered into this 14th day of February 2023 by and between the COUNTY OF LAKE, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and Management Connections (hereinafter referred to as "CONTRACTOR").

**RECITALS**

WHEREAS, the parties hereto have entered into an Agreement dated August 23, 2022 under which CONTRACTOR will provide professional temporary clerical support for Laserfiche scanning project to COUNTY; and

WHEREAS, the parties desire to amend the Agreement to increase the hourly compensation to CONTRACTOR.

NOW, THEREFORE, the parties hereby agree as follows:

**1. Section II – Compensation is hereby amended to read:**

"For services described above, HR shall pay CONTRACTOR an hourly rate, based on hours CONTRACTOR provides staffing.

The hourly rate will depend on the classification of personnel provided and will be billed at the following rates:

- **An Office Assistant that is paid \$15.50 per hour, the cost will be \$22.48 per hour**
- An Office Assistant that is paid \$16.00 per hour, the cost will be \$23.04 per hour
- An Office Assistant that is paid \$17.00 per hour, the cost will be \$24.31 per hour
- An Office Assistant that is paid \$18.00 per hour, the cost will be \$25.56 per hour
- An Office Assistant that is paid \$19.00 per hour, the cost will be \$26.79 per hour
- An Office Assistant that is paid \$20.00 per hour, the cost will be \$28.00 per hour

CONTRACTOR has been selected by COUNTY to provide clerical services to support Laserfiche HR file scanning project. Compensation to CONTRACTOR shall not exceed seventy-five thousand dollars (\$75,000).


The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
