Progress

In 2025, RRA accomplished the following:

- **Hosted 12 monthly meetings** in varying locations across Lake County
- **Hosted 4 Special Meetings**
 - 2 Meetings on providing DEI Trainings
 - 1 Public Town Hall on Water Use for Fire Suppression
 - 1 Public Town Hall on the Lake County Climate Adaptation Plan
- **Convened 3 RRA subcommittees** focused on the topics of biomass utilization and funding coordination
- **Oversaw the completion of the Lake County Biomass Utilization Pilot Project**

1	CAL FIRE Forest Health Grant (CCI) CAL FIRE Forest Health Grant (Prop. 4)		Forest Health projects must advance long-term forest and watershed resilience by applying a balanced and integrated suite of treatments across large landscapes. Eligible activities include, but are not limited to, improved forest management, fuels reduction, prescribed fire, cultural fire, prescribed grazing, pest management, reforestation, biomass utilization, forest watershed restoration, upper watershed, riparian, and mountain meadow restoration, and activities that promote long-term carbon storage and sequestration. Projects that strategically integrate multiple activity types and are implemented through experienced, multi-partner collaborations may receive priority consideration.	CAL FIRE will enter into grant agreements with local, state, and federal public agencies; Native American tribes; public universities or universities organized as non-profits; special districts; industrial and non-industrial private forest landowners, and non-profit organizations.	\$7,000,000	Not required but encouraged	Concept Papers due March 30, 2026
2		<i>Just Added!</i>	Planning and organizational capacity-building may be included as components of a project, but expenses for such activities may not exceed 10% of the total requested funds. Capacity-building refers to strengthening or improving an organization's long-term ability to deliver forest health projects and implement forest health work.				
3	Wood Innovations Grant Program	<i>Just Added!</i>	The Wood Innovation Grants Program, launched in 2015, stimulates, expands, and supports U.S. wood products markets and wood energy markets to support the long-term management of National Forest System and other forest lands. National focus areas include mass timber, renewable wood energy, and technological development that supports hazardous fuel reduction and sustainable forest management.	For profit entities, State & local governments, Indian Tribes, School districts, Not-for-profit organizations, institutions of higher education, Special purpose districts	Maximum award \$300,000.00	100% match required	April 22, 2026
4	Community Wood Grant Program	<i>Just Added!</i>	The Community Wood Grant Program, launched in 2020, provides funding for grants to install thermally led community wood energy systems or to build innovative wood product manufacturing facilities. The Forest Service expects renewable wood energy systems installed under this program to use the most stringent control technologies. The program places extra emphasis on assisting sawmills in economically challenged areas to retrofit or add advanced technology. - **Biomass Feasibility Study**
 - Describes current market conditions and outlines what is needed to develop biomass utilization market in Lake County
- **Entity Action Plan**
 - Describes the services that the RRA is most well-suited to provide within Lake County and how it may address priority barriers to biomass utilization within Lake County
- **RRA Financial Analysis Study**
 - Focused on identifying feasible mechanisms to provide continued funding
