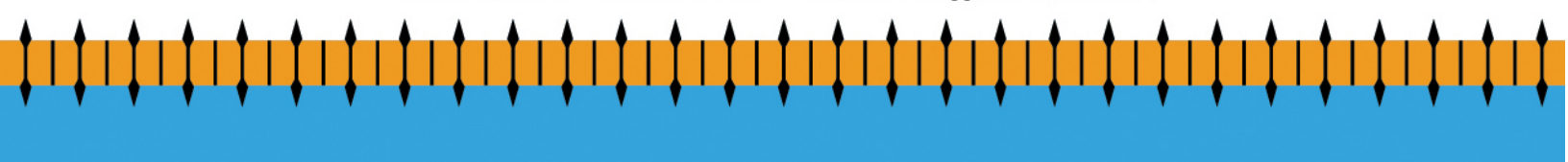
Based on the information discussed at the consultation on March 26, 2021 at 11am, the Tribe has concerns that the project could impact known cultural resources. Please send us the complete cultural resource study along with detailed project information, including any ground disturbance plans for both projects. We highly recommend including cultural monitors during ground disturbance. In addition, we recommend cultural sensitivity training for all project personnel conducted by the Habematolel Pomo of Upper Lake Cultural Resources Department for both projects. Additionally, we request that you incorporate Habematolel Pomo of Upper Lake's Treatment Protocol into the mitigation measures for both projects. Please submit the updated mitigation measures to the Cultural Resources Department once approved and completed.
