AN ORDINANCE AMENDING CHAPTER 5 OF THE LAKE COUNTY CODE AND ADOPTING BY REFERENCE APPENDICES C AND J OF THE 2022 CALIFORNIA BUILDING CODE, PART 2 OF THE CALIFORNIA CODE OF REGULATIONS, TITLE 24

WHEREAS, That certain Building Code known and designated as the 2022 California Building Code and Appendices, B: <u>Board of Appeals</u>, G: <u>Flood Resistant Construction</u>, H: <u>Signs</u>, as based on the 2021 International Building Code, which is published by the International Code Council (ICC), was adopted and enacted on March 7, 2023 as the Building Code of the County of Lake and was made a part of this chapter by reference with same force and effect as if fully set forth herein.

NOW, THEREFORE, THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE DOES ORDAINS AS FOLLOWS:

Section One: The following specified sections of Article I of Chapter 5 of the Lake County Code are each hereby amended to read as follows:

"Sec. 5-4A. – Adoption of Building Code.

4A.1 That certain Building Code known and designated as the 2022 California Building Code and Appendices, B: Board of Appeals, <u>C: Group U – Agricultural Buildings</u>, G: Flood Resistant Construction, H: Signs, <u>J: Grading</u>, as based on the 2021 International Building Code, which is published by the International Code Council (ICC), is adopted and enacted as the Building Code of the County of Lake and is made a part of this chapter by reference with same force and effect as if fully set forth herein."

Section Two: All ordinances or resolutions in conflict herewith are hereby repealed to the extent of such conflict and no further.

Section Three: The Board of Supervisors hereby finds and determines that this Ordinance has been assessed in accordance with the California Environmental Quality Act (Cal. Pub. Res. Code, § 21000 et seq.) ("CEQA") and the State CEQA Guidelines (14 Cal. Code Regs. § 15000 et seq.) and is categorically exempt from CEQA under CEQA Guidelines, § 15061(b)(3), which exempts from CEQA any project where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment. Adoption of the proposed Ordinance would not be an activity with potential to cause significant adverse effect on the environment because the changes made to herein are enacted to provide more protection to the environment, and therefore is exempt from CEQA. It is also exempt from CEQA pursuant to CEQA Guidelines, § 15038 which exempts actions taken by regulatory agencies for the enhancement and protection of the environment. As such, the Ordinance is categorically exempt from CEQA.

Section Four: This ordinance shall take effect thirty (30) days after its adoption and before the expiration of fifteen days after its passage, the Clerk to the Board of Supervisors shall publish a summary of the ordinance with the names of those supervisors voting for and against the ordinance and the clerk shall post in the office of the Clerk to the Board of Supervisors a certified copy of the full text of the adopted ordinance along with the names of those supervisors voting for and against ordinance.
