<p>Please provide a brief description of the type of Tier 2/Tier 3 services you provide through the BHSSA grant.</p>	<p>Lake County Office of Education has continued to provide Specialty Mental Health Services to Lake County students at their school sites. Our goal is to meet the mental health needs of the general education students who are identified by school staff members or self-identified as needing support. We provide individual therapy where the students are most frequently so that we can eliminate barriers to treatment. We are currently providing services for Middletown Unified School District (5 school sites), Lakeport Unified School District (4 school sites), Lucerne Elementary School, Hance Community School and Clearlake Creativity School. Hance and Creativity Schools are LCOE schools that we have been providing services to for years and some of those students have IEPs. We are currently in the process of gaining Medi-Cal certification and establishing services for Upper Lake Unified School District (4 school sites), Konocti Unified School District (7 school sites), Lake County International Charter School and Shade Canyon Charter School. Kelseyville Unified School District has opted to provide their own services for now but we are hoping to return having their students to our caseload soon. We are hiring additional providers to meet these needs.</p>
