4 **RESOLUTION AMENDING RESOLUTION NO. 2021-123 ESTABLISHING SALARIES**
5 **AND BENEFITS FOR EMPLOYEES ASSIGNED TO THE**
6 **CONFIDENTIAL UNIT, SECTION B, FOR OCTOBER 21, 2021 TO JUNE 30, 2025**

7 **WHEREAS**, the Board of Supervisors of the County of Lake, State of California, has
8 approved Resolution No. 2021-123 establishing salaries and benefits for Confidential B
9 employees; and

10 **WHEREAS**, the Board of Supervisors subsequently approved Resolution No. 2021-123
11 including the description of the maximum monthly county contribution for insurance coverage;
12 and

13 **WHEREAS**, The Board now desires to increase the maximum monthly county
14 contribution for insurance coverage to one thousand five hundred dollars (\$1,500.00).

16 **NOW THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of Lake,
17 State of California, that Resolution No. 2021-123 is hereby amended as follows:

- 18 1. Effective July 1, 2023 Section 3, "HEALTH AND LIFE INSURANCE" is hereby
19 amended as follows:

21 **HEALTH AND LIFE INSURANCE**

22 3.1 Maximum Monthly County Contribution for Insurance Coverage

23 The COUNTY shall pay a maximum contribution of one thousand five hundred
24 dollars (\$1,500.00) per month toward the COUNTY-sponsored group medical,
25 dental and vision insurance plan for each employee who enrolls in such a
26 COUNTY sponsored group medical, dental and vision insurance plan.

27
28 Under the COUNTY's flexible benefits plan, a specific amount (as defined in
Section 22892 of the California Government Code, which is adjusted annually
based on inflation) of this contribution is specifically designated for group

1 medical insurance, with the balance of the COUNTY contribution available and
2 paid toward an employee's total group medical, dental, and vision premium.

3
4 In no event shall the COUNTY's financial obligation exceed the actual monthly
5 premium for an employee's medical, dental and vision insurance choices under
6 the County's flexible benefits plan. Employees who select such employee-only
7 coverage and/or employees plus one dependent coverage with total monthly
8 premiums less than one thousand five hundred dollars (\$1,500.00) per month will
9 not be entitled to receive in cash, other compensation, benefits or in any form the
10 difference between the amount of the cost of such coverage and the one thousand
11 five hundred dollars (\$1,500.00) per month COUNTY contribution.

- 12 2. All prior amendments to the description of **HEALTH AND LIFE INSURANCE**
13 **Section 3.1 Maximum Monthly County Contribution for Insurance Coverage** of
14 Resolution No.2021-123 are hereby superseded.

- 15
16 3. Except as specifically modified herein, all other provisions of Resolution No.2021-123
17 shall remain in full force and effect.
