#### Amendment No. 5 to the Agreement Between County of Lake and Management Connections for Temporary Staffing in the Lake County Health Services Department

This Amendment No. 5 to the Agreement is made and entered into this 25<sup>th</sup> day of April, 2023 by and between the COUNTY OF LAKE, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and Management Connections (hereinafter referred to as "CONTRACTOR").

## RECITALS

WHEREAS, The parties hereto have entered into an Agreement dated July 1, 2021 under which CONTRACTOR will furnish personnel to provide customer service, data entry, clerical and bilingual services, and assigned support or lead roles at COUNTY COVID vaccine clinics; and

WHEREAS, The Agreement was amended on October 26, 2021 to extend the term, and maximum compensation of the original agreement; and

WHEREAS, the Agreement was further amended on December 14, 2021 to further extend the term and proportionately raise the maximum compensation; and

WHEREAS, the Agreement was amended again on June 7, 2022 to update the hourly rate tables; and

WHEREAS, the Agreement was further amended on July 12, 2022 to further extend the term and

WHEREAS, the parties wish to further amend the Agreement as to extend the term; and wish to further amend the Agreement as to Compensation rates; and

NOW, THEREFORE, the parties hereby agree as follows:

### A. Section III – Term is amended to read:

The Agreement shall commence on July 1, 2021, and shall terminate on December 31, 2023. For services described, COUNTY shall pay CONTRACTOR an hourly rate, based on hours CONTRACTOR provides staffing. The hourly rate will be billed at the following rates:
