## Complaint Description

Hello,

I am concerned about planning of two cannabis grows on High Valley Road in Clearlake Oaks, Lake County that has Schindler Creek running through it but was not properly addressed in project plans. Schindler historically has been Hitch, or Chi, spawning habitat.

Has a Construction General Permit prior to the initiation of construction. In conjunction with enrollment under this Permit, a Stormwater Pollution Prevention Plan, Erosion Control Plan, and a Hazardous Materials Management/Spill Response Plan been approved for Poverty Flats, 10535 High Valley Rd and/or Liu Farms, UP 20-33, 8531 High Valley Rd.

Also, this may not be your department but both of these are surrounded by federal lands so no legal transporting of the controlled class 1 drug can be moved in or out but when brought to county counsel their reply was we have not been sued nor ever would be likely because it hasn't happened so far. Can you suggest a federal agency that might offer guidance or how to comment properly to the Board of Supervisors?
