This year was an exceptionally competitive grant year, the request in funding was almost \$4.9M and we only had \$2M available to award. Thank you for your notice regarding the 2025 Quagga and Zebra Mussel Infestation Prevention Grant Program. While we understand the importance of adhering to all grant submission requirements, we respectfully request your reconsideration of our application titled *Clear Lake Mussel Prevention Project*, submitted by the Lake County Watershed Protection District.

We acknowledge the absence of the California Department of Fish and Wildlife (CDFW) Prevention Plan Acceptance Letter in our application. Unfortunately, this oversight occurred during the final stages of submission and was not reflective of the completeness or readiness of our prevention plan. Our CDFW-approved plan has been in place and

actively implemented, and we are prepared to submit the acceptance documentation immediately upon request (also attached here).

The funding for this project is critical to sustaining our county-wide invasive mussel prevention program. Without this support, the long-standing efforts to protect Clear Lake—a high-risk and high-value waterbody—from quagga and zebra mussel infestation face serious disruption. The absence of consistent inspection and decontamination services could result in regional ecological and economic harm, with broader implications for downstream water systems and state-managed resources.

We ask for the opportunity to remedy the submission gap and provide the missing CDFW letter. If reconsideration of our application is not possible at this time, we would appreciate any opportunity for provisional support or eligibility for emergency funding, as the potential program impacts extend beyond local boundaries and could undermine state-level prevention efforts.

Thank you again for your ongoing partnership and support. Please let us know if there is any way our agency may work with DBW to ensure continuity of this essential program.
