

**AMENDMENT No. 1 to the MEMORANDUM OF UNDERSTANDING
(MOU) BETWEEN LAKE COUNTY DEPARTMENT OF HEALTH

BEHAVIORAL HEALTH SERVICES FOR THE SAFE RX COALITION

This Amendment No. 1 to the Memorandum of Understanding (MOU) is made and entered into by and between Lake County Behavioral Health Services, hereinafter referred to as "LCBHS," and Lake County Health Services Department, hereinafter referred to as "LCHSD," collectively referred to as the "parties."

WHEREAS, LCBHS and LCHSD continue to work in partnership to move the dial on Opioid misuse and overdose, as well as substance use and mental health issues intersecting with Opioid misuse, and;

WHEREAS, LCBHS has allocated funding to support the work of the Safe Rx program for Fiscal Year 2023-24 in the amount of \$40,000, and;

WHEREAS, the item 2, "**Compensation,**" and Exhibit B, "**Fiscal Provisions,**" of the MOU must be amended to increase the total funding to include Fiscal Year 2023-24.

NOW THEREFORE, based on the forgoing recitals, the parties hereto agree as follows:

A. The title of the Agreement is hereby amended to read:
Memorandum of Understanding (MOU) Between Lake County Department of Health Services, Public Health Division and Lake County Behavioral Health Services for the Safe RX Coalition FY 2022-24.

B. Section 2 – COMPENSATION is hereby amended to read:

Compensation from LCBHS shall not exceed **eighty thousand dollars (\$80,000.00)**. Compensation from LCBHS is contingent upon the appropriation of federal, State, and county funds.

 - iii) 07/01/2023 - **twenty thousand dollars (\$20,000)**
 - iv) 01/01/2024 - **twenty thousand dollars (\$20,000)**
