




Goals of the Governor's Office of Planning & Research (OPR)

- Create a Sustainable Wood Products Market in California

ADDRESS FEEDSTOCK BARRIERS THROUGH PILOT PROJECTS

- Establish reliable access to woody feedstock through a variety of feedstock aggregation mechanisms and organizational innovations.
- Improve feedstock supply chain logistics within each target region through an institutional arrangement with the structure, authority and resources to aggregate and initiate long-term feedstock contracts.
- Explore and assess market opportunities of potential woody biomass businesses in each target region.
- **Increase feedstock aggregation** on all relevant land types, including private and non-commercial land, especially where opportunity exists to produce community fire resilience benefits.





PUBLIC INFRASTRUCTURE JPA

• Formed to be directly involved in funding public infrastructure like a biomass utilization campus, a sort yard, or biomass conversion or utilization facilities.





SERVICES JPA

• A JPA formed to provide a menu of community services and may own equipment to lease to new businesses or the community.

WILDFIRE PREVENTION JPA

• A JPA with the primary focus of paying for fuel treatment activities





BIOECONOMY DEVELOPMENT OPPORTUNITY ZONE DESIGNATION

- The Bioeconomy Development Opportunity Zone Initiative enables communities to powerfully leverage biomass assets to serve as anchors for clean energy economic development.
- **BDO Zones are force-multipliers** for de-risking and attracting investment into new plants that produce sustainable aviation fuel and advanced biofuels, renewable chemicals, biogas, and other biobased manufacturing products.
- **BDO Zone risk ratings** drive biobased investment and create clean energy jobs. They help stand up new biobased production plants that decrease GHGs in a meaningful way.
- They can help secure our clean energy future.

YEAR 1 GOALS FOR RRA

- Creation of a public entity model report to guide how to modify the existing RRA to operate as a woody biomass feedstock broker.
- Summary and report of recently completed feedstock feasibility assessments in the county
- Creation of a sustainable financing model report.

- Pursue Bioeconomy Development Zone designation
