AN ORDINANCE AMENDING SEWER USE ORDINANCE, (APPENDIX A), OF THE LAKE COUNTY
ORDINANCE CODE INCREASING SEWER USE FEES

The Board of Directors of the Lake County Sanitation District, State of California, ordains as follows:

SECTION 1: Paragraph (B) of Section 721 of the Sewer Use Ordinance, (Appendix A), of the Ordinance Code of Lake County is hereby amended to read as follows:
