A RESOLUTION TEMPORARILY AUTHORIZING A ROAD CLOSURE, PROHIBITING PARKING AND AUTHORIZING REMOVAL OF VEHICLES AND ORDERING THE DEPARTMENT OF PUBLIC WORKS TO POST SIGNS

WHEREAS, the Kelseyville Business Association has scheduled the Kelseyville Pear Festival Parade and Events to be held from 6:00 a.m. September 26, 2025, through 7:00 p.m. September 27, 2025; and

WHEREAS, Main Street, County Road No. 522V, First Street, County Road No. 522A, Second Street, County Road No. 522B, Third Street, County Road No. 522C, Fourth Street, County Road No. 522D, and Fifth Street, County Road No. 522E, will need to be closed in order to provide an adequate and safe area for vendors, displays, and parade route; and

WHEREAS, Gunn Street, County Road No. 522G; Live Oak Drive, County Road No. 516 and State Street, County Road No. 522 will provide an adequate and safe route for a detour around said blocked County roadways; and

WHEREAS, Section 21101, subdivision (e) of the Vehicle Code authorizes this Board to temporarily close a portion of any street where signs are posted giving notice of the closure; and

WHEREAS, Section 22651, subdivision (n) of the Vehicle Code, authorizes this Board to prohibit parking and to remove vehicles where signs are posted giving notice of the removal.

NOW, THEREFORE, the Board of Supervisors of the County of Lake does hereby find, determine, resolve and order as follows:

- No person shall operate any vehicle in the following locations from 6:00 a.m. on September 26, 2025 through 7:00 p.m. on September 27, 2025.
 - (a) On Third Street, County Road No. 522C, from its intersection with Church Street, County Road No. 522Q to its intersection with Main Street, County Road No. 522V.

- (b) On Fourth Street, County Road No. 522D, from its intersection with Church Street, County Road No. 522Q to its intersection with Main Street, County Road No. 522V
- 2. No person shall operate any vehicle in the following locations from 6:00 a.m. through 7:00 p.m. on September 27, 2025:
 - (a) On Main Street, County Road No.522V, from its intersection with State Street, County Road No. 522 to its intersection with Gunn Street, County Road No.522G.
 - (b) On First Street, County Road No. 522A, from its intersection with Gard Street, County Road No. 522M to its intersection with Main Street, County Road No. 522V.
 - (c) On Second Street, County Road No. 522B, from its intersection with Gard Street, County Road No. 522M to its intersection with Church Street, County Road No. 522Q
 - (d) On Third Street, County Road No. 522C, from its intersection with Church Street, County Road No. 522C to its intersection with Gaddy Lane, County Road No. 505
 - (e) On Fourth Street, County Road No. 522D, from its intersection with Saderlund Street, County Road No. 522P to its intersection with Main Street, County Road No. 522V
 - (f) On Fifth Street, County Road No. 522E, from its intersection with Saderlund Road, County Road No. 522P to its intersection with Church Street, County Road No. 522Q.
 - (g) On Saderlund Street, County Road No. 522P, from its intersection with Gunn Street, County Road No. 522G to its intersection with Third Street, County Road 522C
 - (h) On Saderlund Street, County Road 522P, from Fourth Street, County Road 522D to Fifth Street, County Road No. 522E.

- 3. No person shall park any vehicle in the following locations from 6:00 a.m. through 7:00 p.m. on September 27, 2025:
 - (a) On both sides of Gunn Street, County Road No. 522G, from its intersection with Main Street, County Road No. 522V to its intersection with Gard Street, County Road No. 522M.
 - (b) On both sides of State Street, County Road No. 522, from its intersection with Main Street, County Road No. 522V to its intersection with Sylar Lane, County Road No. 522N.
 - (c) On both sides of Main Street, County Road No. 522V, from its intersection with State Street, County Road No. 522 to State Highway 29.
 - (d) On both sides Live Oak Drive, County Road No. 516, from its intersection with Main Street, County Road No. 522V to its intersection with State Highway 29.
 - (e) On both sides of Seventh Street, from its intersection with Live Oak Drive, County Road No. 516 to its intersection with Church Street, County Road No. 522Q.
 - (f) On Both Sides of Sixth Street, County Road 522F, from its intersection with Church Street, County Road No. 522Q to its intersection with Main Street, County Road No. 522V.
 - (g) On both sides of Fifth Street, County Road No. 522 E, from Church Street, County Road No. 522Q to its end.
 - (h) On both sides of Bell Hill Road, County Road No. 510, from its intersection with Main Street, County Road No. 522V to State Highway 29.
 - (i) On both sides of Third Street County Road No. 522C, from Gaddy Lane, County Road 505 to Main Street, County Road 522P
