

**Amendment No. 1 to the AGREEMENT BETWEEN COUNTY OF LAKE
AND NORTH VALLEY BEHAVIORAL HEALTH, LLC. FOR ACUTE
INPATIENT PSYCHIATRIC HOSPITAL SERVICES AND
PROFESSIONAL SERVICES ASSOCIATED WITH ACUTE INPATIENT
PSYCHIATRIC HOSPITALIZATION
FOR FISCAL YEAR 2021-22**

This Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as "County," and North Valley Behavioral Health, LLC., hereinafter referred to as "Contractor," collectively referred to as the "parties."

RECITALS

WHEREAS, the parties hereto have entered into an Agreement dated July 1, 2021 under which contractor will provide specialized mental health services for the residents of Lake County; and

WHEREAS, the parties now desire to amend the Agreement to increase the total compensation payable under the Agreement by \$440,000.00 for a new contract maximum of **Eighty Hundred Forty-Thousand Dollars (\$840,000.00)**.

NOW, THEREFORE, the parties hereto agree to the following Amendment to the Agreement:


