ADOPT RESOLUTION APPROVING COUNTY OF LAKE HEALTH SERVICES TO APPLY FOR
FUNDING IN THE AMOUNT OF \$465,591 THROUGH THE CALIFORONIA DEPARTMENT OF PUBLIC
HEALTH (CDPH) FOR FISCAL YEARS 2025 THROUGH 2026 AND AUTHORIZE THE DIRECTOR OF
HEALTH SERVICES TO SIGN SAID APPLICATION

WHEREAS, County of Lake, Department of Health Services, Public Health Division has received notification of funding through the California Department of Public Health (CDPH), Health Care Program for Children in Foster Care (HCPCFC), Administrative (HCPCFC-Admin), Base (HCPCFC-Base), Monitoring Oversight of Foster Children Treated with Psychotropic Meds (HCPCFC-PMMO) and Caseload Relief (HCPCFC-CR).

WHEREAS, The Health Care Program for Children in Foster Care (HCPCFC) is a public health nursing program that provides public health nurse (PHN) expertise in meeting the medical, dental, mental and developmental needs of children and youth in foster care; and

WHEREAS, The Health Care Program for Children in Foster Care, Administrative (HCPCFP-ADMIN), provides funding to assist with case coordination, medical appointment scheduling, and access to treatment services for qualifying children; and

WHEREAS, The Health Care Program for Children in Foster Care, Base (HCPCFC-Base), provides funding for the foundation of program's ability to meet state mandates and maintain essential services countywide. It provides for Public Health Nursing staff who ensure that children and youth in foster care receive required health assessments, coordination of care, and follow -up services; and staff who ensure that children and youth in foster care receive required health assessments, coordination of care, and follow-up services. This funding forms the foundation of the program's ability to meet state mandates and maintain essential services countywide: and

Foster Children Treated with Psychotropic Meds (HCPCFC-PMMO), allows Public Health Nurse's to perform administrative activities in order to oversee psychotropic medication usage in foster children, including additional case level oversight of prescription medications, and by supporting the facilitation of the judicial oversight of psychotropic medications; and

WHEREAS, The Health Care Program for Children in Foster Care, Caseload Relief (HCPCFP-CR), provides funding to assist our local program in reducing Public Health Nurse Caseloads.

NOW THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Lake hereby authorizes the Health Services Director to execute in the name of County of Lake, State of California all necessary applications, contracts, payment request, agreements, and certification statements for the purposes of securing grant funds and to implement and carry out the purposes specified in the application. A copy of the Resolution shall be delivered to the Lake County Auditor/Controller.
