Quote includes delivery & installation of 28 buoys. Lake County to supply boat and forklift for installation. Also includes first year of Interactive Algae Control (IAC) & Data download.

Herein is a purchase agreement between LG Sonic US, LLC, and the Water Resources Department of Lake County (the "Parties"), dated 2023-11-03. The Parties shall execute the agreement according to the following schedule. In Year One (1), the Water Resources Department of Lake County shall pay a sum of \$754,510, equal to 50% of the total System purchase price. In Year Two (2), the Water Resources Department of Lake County shall pay a sum of \$399,215, equal to the sum of 25% of the total System purchase price, \$377,255, and Interactive Algae Control, \$21,960. Pursuant to the Water Resources Department of Lake County's evaluation of System performance, in Year Three (3) it shall pay a sum of \$399,215, equal to the sum of 25% of the total System purchase price, \$377,255, and Interactive Algae Control, \$21,960. In the event of a positive System performance assessment, the Water Resources Department of Lake County shall assume full System ownership upon LG Sonic US, LLC's receipt of the final Year Three (3) payment.

In the event of a negative System performance assessment, the Water Resources Department of Lake County shall retain 9 of the MPC buoys, equal to three (3) MPC-Buoy Pro and six (6) MPC-Buoy Lite units. LG Sonic US, LLC shall recover the remaining MPC Buoys with assistance of Lake County to assist in removal.
