AMENDMENT TWO TO THE ENGINEERING SERVICES AGREEMENT FOR STAFF AUGMENTATION SERVICES IN LAKE COUNTY, CALIFORNIA

This Amendment Two of the Engineering Services Agreement ("AMENDMENT TWO") is made				
this _	day of	,2024, by and between the County of Lake, hereinafter referred		
to as	"COUNTY" and C	oastland Civil Engineering, LLP, hereinafter referred to as "ENGINEER"		

WITNESSETH

WHEREAS, on November 14, 2023, the Lake County Board of Supervisors ("BOARD") approved the Engineering Services Agreement for Staff Augmentation ("AGREEMENT") dated November 14, 2023, between the COUNTY and ENGINEER in an amount not to exceed \$250,000.00 per year for a period of three years: and

WHEREAS, ON June 7, 2024, the BOARD executed Amendment One ("AMENDMENT ONE") to the AGREEMENT dated May 21, 2024, which changed the applicable period for the not-to-exceed amount from each calendar year to each fiscal year; and

WHEREAS, COUNTY AND ENGINEER in accordance with the AGREEMENT desire to amend said AGREEMENT to increase the not-to-exceed amount from \$250,000.00 per year to \$750,000.00 from July 1, 2024 to June 30, 2025 (FY2024/FY2025) and adjust personnel rates for the same period.

NOW, THEREFORE, the parties hereto agree as follows:

Section 14 is hereby modified to read as follows:

"14. Payment for services covered by this AGREEMENT shall be made on a Time and Materials basis, with a not-to-exceed amount of \$250,000.00 for each fiscal year (FY2023/FY2024, FY2024/2025, FY2025/2026, FY2026/2027)

All ENGINEER charges for services between November 14, 2023, and June 30, 2024, will be reimbursed and counted towards Fiscal Year 2023/2024.

Rates paid for the various classifications of workers shall be in accordance with the Rate Sheet included as "Attachment B" of this AGREEMENT.

Staff oversight is expected to be performed by individuals at a "Supervising Engineer" unless other approved by the COUNTY prior to the start of work.

ENGINEER shall provide a written scope of services together with an estimate of staff hours and cost and receive authorization from COUNTY prior to beginning work on specific projects unless otherwise specified in the COUNTY work request.

ENGINEER shall submit separate invoices for each project or work request.

Payments for services provided in FY 2024/2025, from July 1, 2024, to June 30, 2025, shall not exceed \$750,000.00.

The attached "Schedule of Hourly Rates July 1, 2024 to June 30, 2025 are incorporated into 'Attachment B' of the AGREEMENT."

Section 15 is hereby modified to read as follows:

"15. This AGREEMENT shall remain in full force for a period of four (4) fiscal years (FY2023/FY2024, FY2024/2025, FY2025/2026, FY2026/2027), or unless terminated by either party. COUNTY shall have the right to terminate this AGREEMENT without cause by giving ENGINEER thirty (30) days written notice. ENGINEER shall have the right to terminate this AGREEMENT only after an assigned project has been completed to the satisfaction of the COUNTY and then only after thirty (30) days written notice to COUNTY."

Attachment "B" attached to this Amendment Two, hereby replaces Attachment "A" of the AGREEMENT.

Except as specifically modified herein, all other terms and conditions of the AGREEMENT and AMENDMENT ONE shall remain in full force and effect.

COUNTY and ENGINEER have executed this Amendment Two to the AGREEMENT on the day and year first written above.
