3 **RESOLUTION ADOPTING AN AMENDMENT TO THE**
4 **LAKE COUNTY GENERAL PLAN (GPAP 23-01)**

5 **WHEREAS**, the Board of Supervisors of the County of Lake has conducted a
6 public hearing on an amendment to the Lake County General Plan which is designated
7 as GPAP 23-01; and

8 **WHEREAS**, the Planning Commission has conducted a public hearing on the
9 aforementioned amendment to the Lake County General Plan and recommends that
10 the Board of Supervisors approve of the General Plan Amendment (GPAP 23-01) with
11 the reasons therefore.

12 **NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS**
13 **OF THE COUNTY OF LAKE, THAT IT FINDS, DETERMINES, ORDERS AND**
14 **HEREBY DECLARES AS FOLLOWS:**

15 1. The Board of Supervisors hereby adopts this General Plan Amendment
16 (GPAP 23-01) consisting of the General Plan proposals of Reynolds Systems, Inc. as
17 set forth in Exhibits "A".

18 2. The adoption of the General Plan amendment set forth in Section 1 is in
19 the public interest.

20 3. The Board of Supervisors has reviewed and considered the
21 environmental effects of sub-parts GPAP 23-01 of this General Plan amendment as
22 set forth in the negative declarations (IS 23-03) that were adopted for those sub-parts
23 of this amendment and approve said negative declarations.

24 4. The Clerk of the Board is hereby directed to file a Notice of
25 Determination on the sixth working day after this General Plan amendment is
26 approved and adopted.

5. The Clerk of the Board is hereby directed to endorse this General Plan amendment to show that it has been approved by the Planning Commission and that it was adopted by the Board of Supervisors.
