**WHEREAS**, monies in the amount of \$ 69,897.00 is a result of increased unanticipated revenue from the Unclaimed Gas Tax (UCGT) and Department of Pesticide Regulation licensed cannabis permit activity reimbursements that have been received in FY23/24

**WHEREAS**, unanticipated revenue in the amount of \$69,897.00 is needed in the Agricultural Commissioner Budget Unit 2601 for aquatic weed control.
