It is my pleasure to present the 2024 Lake County Crop and Livestock Report that is prepared pursuant to Sections 2272 and 2279 of the California Food and Agricultural Code. This report summarizes the acreage, production and gross value of agricultural commodities produced in Lake County. This report reflects gross values only and does not represent actual net return to the producers.

Lake County's estimated total gross production value for 2024 was \$101,941,265. This is a 27% decrease from 2023.

Wine grapes were the number one crop with a gross value of \$74,843,331 which is a decrease of 35% from 2023. The total tonnage was 50,869 and the total grape acreage was 10,609 acres which are both decreases from 2023.

Pears were the number two crop with a gross value of \$12,917,779 which is a decrease of 34% from 2023. The total tonnage was down from 2023, and total pear acreage remains the same at 1,347.5 acres.

There were notable increases in walnuts, livestock production and vegetable crops. Other increases were noted in livestock & poultry products and field & seed crops. Decreases were noted in nursery production and timber production.

I wish to express my appreciation to the many agricultural producers and others who provided information to make this report possible. A sincere thank you to the staff of the Agriculture/Weights & Measures Department who collected and compiled data for this report.
