4 **A RESOLUTION AMENDING RESOLUTION NO. 2025-72 ESTABLISHING**
5 **SALARIES AND BENEFITS FOR MANAGEMENT EMPLOYEES FOR THE PERIOD**
6 **OF JULY 1, 2025 TO JUNE 30, 2029**

7 **WHEREAS**, the Board of Supervisors of the County of Lake, State of California,
8 approved Resolution No. 2025-72 establishing salaries and benefit for management employees
9 for the period of July 1, 2025 to June 30, 2029

10 **WHEREAS**, due to typographical errors in the Management Leave benefits section, the
11 resolution incorrectly stated that employees are entitled to six weeks of vacation after 20 years of
12 continuous service.

13 **WHEREAS**, the Management Resolution omitted the Class A/B Differential for
14 management employees;

15 **NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of Lake,
16 State of California, that it finds, determines, and hereby declares that effective July 1, 2025:

17 **1. CLASS A/B DIFFERENTIAL**

18 Employees who are required to possess a Class A/B driver's license due to the
19 minimum requirements of the job description, shall receive a two and one-half
20 percent (2.5%) of their base salary.

21 **2. LEAVE BENEFITS**

22 **Vacation Leave**

23 The following annual allowance shall be credited to each employee, other than
24 elected officials, based upon full-time continuous permanent employment with the
25 County:

Years of Service	Annual Vacation Accrual
Beginning the 1 st year through the end of the 5 th year	3 weeks
Beginning the 6 th year through the end of the 20 th year	4 weeks
After 20 or more years of continuous service	5 weeks

1 3. Except as specifically modified herein, all other provisions of Resolution No. 2025-72
2 shall remain in full force and effect.
