Dear Sheriff McGarva,

This letter serves as formal documentation of the authorized transfer and sale of twenty (20) department-owned Remington 870, 12-gauge shotguns equipped with 18-inch barrels from the Lake County Sheriff's Office to the Lassen County Sheriff's Office. The purpose of this transfer is to support your agency's operational readiness and to ensure continued law enforcement use of these serviceable firearms.

Pursuant to the authority provided under California Penal Code § 30150, law enforcement agencies are permitted to acquire and transfer firearms without being subject to the standard dealer-processing requirements that apply to non-law-enforcement transactions. Specifically, PC 30150 authorizes "the loan, acquisition, or transfer of a firearm between law enforcement agencies when authorized by the head of each agency," and confirms that such transactions are exempt from the dealer-delivery and private-party transfer statutes normally applicable under California law. This transfer is conducted in accordance with that statutory authority, with full approval from both agency heads.

The Lake County Sheriff's Office has verified the serial numbers, condition, and serviceability of each shotgun prior to release. A complete serialized inventory list is included as Attachment A. Upon physical delivery and acceptance by your agency, the attached property acceptance form will be completed and included as Attached B. Additionally, the Lassen County Sheriff's Office will assume responsibility for entering the firearms into the Automated Firearms System (AFS) as institutional weapons, consistent with DOJ reporting requirements and internal policy.

All twenty (20) shotguns are being transferred as-is, and the agreed-upon sale price between our agencies is \$200.00 per unit totaling \$4,000.00. Payment arrangements may be completed via agency invoice, financial transfer, or other mutually agreed method.


