#### Amendment No. 2 to the AGREEMENT BETWEEN COUNTY OF LAKE AND VICTOR TREATMENT CENTERS, INC FOR SPECIALTY MENTAL HEALTH SERVICES FOR FISCAL YEAR 2023-24

This 2<sup>nd</sup> Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as "County," and Victor Treatment Centers, INC., hereinafter referred to as "Contractor," collectively referred to as the "Parties."

#### RECITALS

**WHEREAS**, the County entered into an Agreement with Contractor effective July 1, 2023; and

**WHEREAS,** the parties amended the Agreement to correct an error in the Agreement where the Contractor name was noted as "Victor Treat Centers," when it should have read "Victor Treatment Centers, INC."; and

**WHEREAS**, the parties now desire to amend the Agreement a second time to increase the total compensation payable under the Agreement by \$150,000.00 for a new contract maximum of \$200,000.00 and must amend item three, "Compensation," to reflect this change.

**NOW, THEREFORE,** based on the forgoing recitals, the parties hereto agree as follows:

Any reference to "Victor Treatment Centers" in the Agreement as amended is hereby amended to state: "Victor Treatment Centers, INC."

Section 3, "Compensation," is hereby amended to state the following:

3. <u>COMPENSATION</u>. Contractor has been selected by County to provide the services described hereunder in Exhibit A, titled, "Scope of Services." Compensation to the Contractor shall not exceed Two Hundred Thousand Dollars (\$200,000.00).

The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in **Exhibit B**, titled, "**Fiscal Provisions**," attached hereto and incorporated herein, provided that Contractor is not in default under any provisions of this Agreement. Compensation to Contractor is contingent upon appropriation of federal, state and county funds.
