

FIRST AMENDMENT TO CONTRACT BETWEEN COUNTY OF LAKE AND FISCAL EXPERTS, INC. FOR TIME STUDY SERVICE

This First Amendment to Contract is made and entered into on the date executed herein below, by and between the County of Lake through its Department of Social Services, hereinafter referred to as "LCDSS", and Fiscal Experts, Inc. hereinafter referred to as "Contractor"; collectively referred to as the "parties".

Whereas, the original Contract was executed on August 04, 2020 for the term of July 1, 2020 to June 30, 2023;
and

WHEREAS, there is a need to update the term.

NOW, THEREFORE, the parties hereto agree as follows:

Page 1, Section 1 entitled "Term" is hereby amended to read as follows:

"This Contract shall commence on July 1, 2020, and shall terminate on December 31, 2023, unless earlier terminated as hereinafter provided. In the event LCDSS desires to temporarily continue services after the expiration of this Contract, such continuation shall be deemed on a month-to-month basis, subject to the same terms, covenants, and conditions contained herein."

Except as specifically modified herein, all other terms and conditions of the original Contract shall remain in full force and effect.
