RE: Request for Support of Changes to BGN Policies in Response to President Donald J. Trump's Executive Order "Restoring Names that Honor American Greatness," Corresponding Changes to CACGN Policies and Practices

Honorable Secretary Crowfoot and Members of the California Advisory Committee on Geographic Names (CACGN),

The purpose of this correspondence is to supplement the Lake County Board of Supervisors' December 10, 2024, Letter (attached, for your reference) sent to the United States Board on Geographic Names' (BGN's) Domestic Names Committee (DNC). Secretary Crowfoot and CAGN (cacgn@resources.ca.gov) were copied on this emailed submittal.

As you will be aware, on January 20, 2025, President Donald J. Trump issued an Executive Order, "Restoring Names that Honor American Greatness" (attached). Section 2(c) of the Executive Order expressly permits the BGN Board to update its principles, policies, and procedures with respect to all applications proposing a name change within the BGN's authority.

In light of the foregoing, the County of Lake is requesting the BGN develop, update, and expand their procedures and policies to address specific issues concerning proposals to rename unincorporated "Populated Places." Populated Places are communities where people live, work, and own businesses, and the current policies and procedures lack clarity, contain conflicting information, and have generally frustrated the residents of Lake County. Consideration should be given to developing robust policies and procedures that support the local government and promote community consensus-building and transparency. Said policies should incorporate the following:

- Upon BGN's acceptance of an application, initiate interagency and governmental consultation and coordination to delineate the process, assign roles and responsibilities, and design a process to effectively interface with the public.
- Define a process for Public Comment in a manner that would encourage public participation and allow for appropriate transparency surrounding BGN decision-making.
- Address multiple or competing applications involving the same area.
- Develop a process for "alternate names" upon the submission of an application to BGN.
- Provide definitions of "populated areas" and "towns and townships" and clarify the naming authorities when unincorporated "towns" in California are under the governing authority of the County.

- Coordinate with state and local naming committees to support public engagement in the form of Frequently Asked Questions (FAQs), informational webinars, and community listening sessions.

Our Board requests your support of BGN incorporating these concepts in their policy revisions and further requests CACGN consider updating your own policies to coordinate with BGN, local government, Tribes, and the public.

Effective collaboration between BGN and CACGN would promote transparency, support local government, encourage public participation, and reduce overall confusion and frustration with the process. In addition to the recommendations above, please consider the following suggestions to improve communication and outreach:

- Assign a CACGN staff member as a liaison between BGN and local government.
- CACGN liaison to lead Community listening sessions and informative webinars.
- Develop a transparent process for Public Comment received by CACGN.

Name Change Proposals profoundly affect populated communities. Lake County residents have been deeply frustrated by difficulty obtaining clear and consistent information from both Federal and State naming authorities; changes to policies and procedures are needed, and this work needs to be appropriately resourced. The Lake County Board of Supervisors appreciates your earnest consideration of these comments.
