**A RESOLUTION AMENDING RESOLUTION NO. 2025-118 TO AMEND THE ADOPTED BUDGET FOR FY 2025-26 BY INCREASING REVENUES AND APPROPRIATIONS IN BUDGET UNIT 1904-INFORMATION TECHNOLOGY**

WHEREAS, Government Code Section 29130 provides that anticipated revenue may be made available for specific appropriation by a four-fifths vote of the Board at any regularly scheduled or properly noticed special meeting; and

WHEREAS, The California Collaborative Connectivity (CCC) Grant, administered by the California Library Connect program and funded by the California State Library, is a funding opportunity designed to strengthen broadband infrastructure in public libraries across California; and

WHEREAS, the County of Lake has been awarded \$210,000 in CCC grant funds; and

WHEREAS, the funds will be utilized for network modernization and security improvements, inside wiring modernization at the Lakeport, Redbud, and Upper Lake Libraries, and technical network training for Library IT support staff.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Lake, State of California, that it finds, determines, and hereby declares that the County of Lake Adopted Budget for Fiscal Year 2025/26 is amended as follows:


