

AGREEMENT FOR EASTLAKE SANITARY LANDFILL PHASE 1 CELL CONSTRUCTION

THIS AGREEMENT, made this _____ day of _____, 2024, by and between the COUNTY OF LAKE, hereinafter called "OWNER" and Rege Construction, Inc., doing business as a corporation, hereinafter called "CONTRACTOR".

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned:

- (1) The CONTRACTOR will commence and complete the Eastlake Sanitary Landfill, Phase 1 Cell Construction, Project Bid No. 23-32.
- (2) The CONTRACTOR will furnish all of the material, supplies, tools, equipment, labor and other services necessary for the construction and completion of the project described herein.
- (3) The CONTRACTOR will commence the work required by the CONTRACT DOCUMENTS within the time period required by the CONTRACT DOCUMENTS after the date of the Notice To Proceed and will complete the same within the time period required by the CONTRACT DOCUMENTS unless the period for completion is extended otherwise by the CONTRACT DOCUMENTS.
- (4) The CONTRACTOR agrees to perform all of the work described in the CONTRACT DOCUMENTS and comply with the terms therein for the sum of Five Million One Hundred Sixty One Thousand Six Hundred Sixty Three Dollars (\$5,161,663.00), as shown in the CONTRACTOR'S bid.
- (5) The term "CONTRACT DOCUMENTS" means and includes the following:

 - (L) NONCOLLUSION AFFIDAVIT
 - (M) PUBLIC CONTRACT CODE CERTIFICATIONS
 - (N) WORKERS' COMPENSATION PARTICIPATION CERTIFICATION
 - (O) LOCAL WORKFORCE PARTICIPATION CERTIFICATION
 - (P) BIDDER'S QUALIFICATIONS
 - (Q) PAYMENT BOND
 - (R) PERFORMANCE BOND
 - (S) CHANGE ORDERS

(6) The OWNER will pay to the CONTRACTOR in the manner and at such times as set forth in the General Conditions such amounts as required by the CONTRACT DOCUMENTS.

(7) This Agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.
