AB481 California Government Code 7070-7075 Military Equipment



AB481

On September 30, 2021, Governor Newsom signed Assembly Bill 481 ("AB 481"), which became effective on January 1, 2022. AB 481 stated goals are to provide legally enforceable safeguards to protect the public's welfare, safety, civil rights, and civil liberties before military equipment is funded, acquired, or used.

Section 7071 requires each law enforcement agency to obtain approval of the applicable governing body, by adoption of a military equipment use policy, by ordinance at a regular meeting held pursuant to specified open meeting laws, prior to taking certain actions relating to the funding, acquisition, use, or collaboration with another agency in the use, of military equipment. The section requires similar approval for the continued use of military equipment acquired before January 1, 2022.

Because of the low cost and maintenance, they became one of the most commonly used robots abroad. Because of the 1033 Program, many of these military surplus robots were transferred to civilian agencies. Their main purpose in law enforcement has been the detection and disposal of bombs. They have also been utilized in other missions such as threat assessments and reconnaissance, such as entering a building to investigate barricaded subjects and hostage situations.

How used:

This robot is utilized by the LCSO Crisis Response Unit and is used in critical incidents. These missions include barricaded subjects, investigating suspicious items, and hostage situations. The purpose of this robot is to assist in dangerous incidents while maintaining officer and citizen safety.

Distraction Devices

Distractions Devices are used by special tactical units during hostage rescue and high-risk warrant service. In a dangerous situation, these device provide momentary distraction allowing for a safer extraction of hostages or apprehension of dangerous individuals.

Distraction Devices are ATF-controlled Class-C explosive device that emit a bright light and thunderous noise to distract potentially dangerous individuals.

The CTS 7290 is the standard for diversionary flash-bang devices. The 7290 produces a 175db and 6-8 million candelas of light output



Use and Storage:

Robots, Distraction Devices and Chemical munitions are strictly controlled, used and trained with by the Lake County Sheriff's Office Crisis Response Unit (CRU) and Corrections Special Emergency Response Team (SERT) members. They are stored and secured in climate-controlled, and alarmed rooms.

The CRU facility is fenced, has perimeter alarms and 24-hour video and audio surveillance. Only members of CRU have access to the secured room where the Robots, Distraction Devices and Chemical Munitions are stored. Only CRU members are authorized to use and deploy the robots, distraction devices and chemical munitions and only under the direct approval of the CRU commander or Sheriff

Access to chemical munitions and SERT equipment at the Correctional facility is restricted to SERT members. Only SERT members are authorized to deploy chemical munitions, Rubber Ball Impact Devices, FN 303 and equipment, and only under the direct approval of the SERT commander, Correctional facility commander or Sheriff when necessary and appropriate.
