RESOLUTION AMENDING RESOLUTION NO. 2021-124 ESTABLISHING SALARIES AND BENEFITS FOR EMPLOYEES ASSIGNED TO THE MANAGEMENT EMPLOYEES, FOR NOVEMBER 1, 2021 TO JUNE 30, 2025

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Lake, State of California, that Resolution No. 2021-124 is hereby amended as follows:
