

**AMENDMENT NO. 1 AGREEMENT FOR PROVISION OF ADMINISTRATIVE
SERVICES TO LAKE COUNTY TOURISM IMPROVEMENT DISTRICT**

This Amendment No. 1 to Agreement is made and entered into this 12th day of September, 2023 by and between the COUNTY OF LAKE, a political subdivision of the State of California, hereinafter referred to as “COUNTY”, and VISIT LAKE COUNTY CALIFORNIA, hereinafter referred to as “CONTRACTOR”, collectively referred to as the “PARTIES”.

RECITALS

WHEREAS, the parties hereto have entered into an Agreement dated July 1, 2023; and

WHEREAS, the compensation was incorrectly written;

NOW, THEREFORE, the contract shall be amended as follows:

3. COMPENSATION

Contractor has been selected by County to provide the services described hereunder in Exhibit “B” (Scope of Services), attached hereto. **Compensation to Contractor shall not exceed the sum of One Hundred Twelve Thousand, Five Hundred Dollars (\$112,500).**

The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in Exhibit “B” (Fiscal Provisions), attached hereto, provided that Contractor is not in default under any provisions of this agreement. Compensation to Contractor is contingent upon appropriation of federal, state and county funds.

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
