3. COMPENSATION

COLDITY OF LAKE

Contractor has been selected by County to provide the services described hereunder in Exhibit "B" (Scope of Services), attached hereto. Compensation to Contractor shall not exceed the sum of One Hundred Twelve Thousand, Five Hundred Dollars (\$112,500).

The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in Exhibit "B" (Fiscal Provisions), attached hereto, provided that Contractor is not in default under any provisions of their agreement. Conpensation to Contractor is contingent upon appropriation of federal, state and county funds.
