RESOLUTION AMENDING RESOLUTION 2023-116 ADOPTING THE FINAL RECOMMENDED BUDGET FOR FISCAL YEAR 2023-24 TO DECREASE REVENUE AND RESERVES IN FUND 153

WHEREAS, the Board of Supervisors of the County of Lake, by and through adoption of Resolution 2023-116, adopted the Final Recommended Budget for FY 2023-24; and

WHEREAS, Section 29130 of the Government Code provides that the governing body may, by a four-fifths vote, make restricted fund balance available for appropriation; and

WHEREAS, the Adopted Budget for Fiscal Year 2023-24 includes a \$90,000 loan repayment to Fund 153 from Fund 936; and

WHEREAS, the Fund 153 reserve account was increased by \$90,000 to include the funds received from the loan repayment; and

WHEREAS, the loan repayment was completed in Fiscal Year 2023-24 and accrued back to Fiscal Year 2022-23; and

WHEREAS, in order to balance Fund 153, the below adjustments to reserves and revenues are needed;

NOW, THEREFORE BE IT RESOLVED by the Board of Supervisors, County of Lake, State of California, that the following revisions to the Fiscal Year 2023-24 Budget of the County of Lake are hereby ordered and approved as follows:
