## RESOLUTION AUTHORIZING CANCELLATION OF RESERVE ACCOUNTS IN THE AMOUNT OF \$3,167,543.00 TO PROVIDE SUFFICIENT CASH FLOW

#### **RECITALS**

WHEREAS, Section 29125, 29126, 29126.1, and 29130 of the Government Code provide authority for the Board of Supervisors to transfer and revise appropriations, cancel unused appropriations, transfer unused appropriations to contingencies, reduce estimate and cancel appropriate designations and reserves other than the general reserve; and

**WHEREAS**, the Behavioral Health Services Department joined the California Mental Health Services Authority's Semi-Statewide Enterprise Health Record as one of three pilot Counties and went live in the new system March 1, 2023; and

WHEREAS, the Behavioral Health Services Department along with the other two pilot counties have not been able to successfully submit claims for services to the Department of Healthcare Services since the go live date and it is not anticipated this issue will resolve prior to the close of the fiscal year; and

**WHEREAS**, the Behavioral Health Services Department is in a deficit fund balance due to lack of reimbursement for Medicaid claims in March, April, May, that must be resolved prior the close of the 2022-23 fiscal year; and

WHEREAS, there are reserve designations in the Behavioral Health Department which can be made available to provide cash flow to pay invoices for previously contracted work until the successful submission of claims and reimbursement from the Department of Healthcare Services; and

**NOW, THERFORE, BE IT RESOLVED** by the Board of Supervisors, County of Lake, State of California, that the following revisions to the FY 2022-23 Adopted Budget of Lake, including reserves, are hereby ordered and approved:
