

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE  
AUTHORIZING STANDARD AGREEMENT NO. 26-60035 BETWEEN THE COUNTY OF  
LAKE AND THE CALIFORNIA DEPARTMENT OF HEALTH CARE SERVICES AND  
AUTHORIZING THE BEHAVIORAL HEALTH DIRECTOR TO SIGN THE AGREEMENT**

**RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE,  
STATE OF CALIFORNIA, THAT IT FINDS, DETERMINES AND HEREBY DECLARES**, that the Board finds and determines that Standard Agreement No. 26-60035 between the County of Lake (hereinafter referred to as “County”) and the California Department of Health Care Services (hereinafter referred to as “DHCS”) is necessary for the administration of behavioral health programs and services, and the County hereby agrees to enter into said agreement.

**RECITALS**

**WHEREAS**, the California Department of Health Care Services (DHCS) and the County of Lake have negotiated Standard Agreement No. **26-60035** for the administration and oversight of behavioral health programs and services funded through federal and state behavioral health programs; and

**WHEREAS**, the agreement establishes requirements for the County of Lake Behavioral Health Department to administer services and comply with applicable federal and state laws, regulations, and reporting requirements; and

**WHEREAS**, the agreement includes provisions related to program administration, fiscal management, reporting requirements, and compliance with federal and state behavioral health funding sources; and

**WHEREAS**, the agreement term is **July 1, 2026 through June 30, 2029**, and is a **zero-dollar (\$0) agreement** establishing programmatic and compliance requirements necessary for the County to receive and administer behavioral health funding; and

**WHEREAS**, the agreement includes the following incorporated exhibits and attachments, which are attached to and made part of the agreement by reference:

**WHEREAS**, approval of this agreement will allow the County of Lake to continue participating in and administering state and federally funded behavioral health programs in compliance with DHCS requirements.

**NOW, THEREFORE, BE IT RESOLVED**

The Board of Supervisors of the County of Lake hereby approves Standard Agreement No. **26-60035** between the County of Lake and the California Department of Health Care Services and authorizes the Behavioral Health Director to sign the agreement, the Contractor Certification Clause, and any non-substantive amendments or administrative documents required by DHCS.
