RECITALS

WHEREAS, the Health Services Department has been awarded a five-year grant funding agreement renewing the HIV/AIDS Surveillance Program for FY 2025-2029 in the amount of \$50,015 from the State of California, Department of Public Health; and

WHEREAS, the Department of Health Services will operate this program in accordance with the State of California, Department of Public Health Branch Policies to Maintain infrastructure for HIV surveillance, to collect and submit accurate, complete, and timely HIV surveillance data, to maintain data security and confidentiality, and to provide program management and coordination.

THEREFORE BE IT RESOLVED THAT, the Chair of the Board of Supervisors of the County of Lake hereby authorizes the Health Services Director to execute in the name of County of Lake, State of California all necessary applications, agreements, payment requests, and amendments hereto for the purpose of securing grant funds in the amount of \$47,010 for the five-year-grant period and to implement and carry out the purposes specified in the grant agreement.
