SUPPLEMENTAL CONDITIONS

1. Safety and Patrol Boat

Event sponsors will ensure that a safety patrol boat(s) is present during event operations. Team members should include rescue divers, tenders, and boat operator. The patrol boat should also help secure the course area from non-event boats.

2. Aquatic Invasive Species Inspection

All vessels, boats, kayaks, or equipment that will be in contact with water or within 50 ft of shoreline must comply with Lake County's quagga mussel program. Contractor must coordinate with the Invasive Species Program Coordinator, and Corey Hustead, Water Resources Technician, at Corey.Hustead@lakecountyca.gov, for inspection and decontamination of vessels and/or equipment. Ramp Coordinator, Bob Valdez, and a supporting ramp monitor will be present at the event at its entirety to inspect and screen all vessels. Once deemed clean, drained, and dry, vessel owners will then purchase the \$20 Lake County mussel inspection sticker. Failure to comply may result in up to a \$1000 citation for each item in violation, operators, and property owners.

3. Aquatic Invasive Species Inspection

Upon passing the screening inspection, the quagga mussel sticker must be affixed to the boat in a prominent and readily visible location.
